## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school health services, providing
- for school access to emergency epinephrine.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1414.2. School Access to Emergency Epinephrine.--(a)
- 13 A SUBJECT TO SUBSECTION (G), A school entity or nonpublic school <--
- 14 may authorize a trained school employe to:
- 15 (1) provide an epinephrine auto-injector that meets the
- 16 prescription on file FOR EITHER THE INDIVIDUAL STUDENT OR THE <
- 17 SCHOOL ENTITY OR NONPUBLIC SCHOOL to a student who is authorized

- 1 to self-administer an epinephrine auto-injector;
- 2 (2) administer TO A STUDENT an epinephrine auto-injector <--
- 3 that meets the prescription on file to a student who is
- 4 <u>authorized to self-administer an epinephrine auto-injector FOR</u> <--

- 5 EITHER THE INDIVIDUAL STUDENT OR THE SCHOOL ENTITY OR NONPUBLIC
- 6 SCHOOL; and
- 7 (3) administer an epinephrine auto-injector THAT MEETS THE <--
- 8 PRESCRIPTION ON FILE FOR THE SCHOOL ENTITY OR NONPUBLIC SCHOOL
- 9 to a student that the employe in good faith believes to be
- 10 <u>having an anaphylactic reaction.</u>
- 11 (b) Notwithstanding section 11 of the act of April 14, 1972
- 12 (P.L.233, No.64), known as "The Controlled Substance, Drug,
- 13 <u>Device and Cosmetic Act," a physician may prescribe epinephrine</u>
- 14 <u>auto-injectors in the name of the school entity or nonpublic</u>
- 15 school to be maintained for use when necessary PURSUANT TO <--
- 16 SUBSECTION (A).
- 17 (c) A school entity or nonpublic school may maintain at a
- 18 school in a locked, secure location a supply of epinephrine
- 19 auto-injectors.
- 20 (d) A school entity or nonpublic school that authorizes the
- 21 provision of epinephrine auto-injectors under this section shall
- 22 designate one or more individuals at each school who shall be
- 23 responsible for the storage and use of the epinephrine auto-
- 24 injectors.
- 25 (e) Individuals who are responsible for the storage and use
- 26 of epinephrine auto-injectors must successfully complete a
- 27 training program THAT SHALL BE developed and implemented by the <--
- 28 Department of Health WITHIN NINETY (90) DAYS OF THE EFFECTIVE
- 29 DATE OF THIS SECTION.
- 30 (f) (1) An epinephrine auto-injector from the school

- 1 entity's or nonpublic school's supply of epinephrine auto-
- 2 <u>injectors that meets the prescription on file FOR THE SCHOOL</u>
- 3 ENTITY OR NONPUBLIC SCHOOL may be provided to and utilized by a
- 4 student authorized to self-administer or MAY BE ADMINISTERED by <--
- 5 <u>a trained school employe authorized to administer an epinephrine</u>
- 6 <u>auto-injector to the A student PURSUANT TO SUBSECTION (A).</u> <--
- 7 (2) When a student does not have an epinephrine auto-
- 8 <u>injector or a prescription for an epinephrine auto-injector on</u>
- 9 <u>file, a trained school employe may utilize the school entity's</u>
- 10 or nonpublic school's supply of epinephrine auto-injectors to
- 11 respond to anaphylactic reaction under a standing protocol from
- 12 <u>a physician and as provided in this section.</u>
- 13 (F.1) IN THE EVENT A STUDENT IS BELIEVED TO BE HAVING AN <--
- 14 ANAPHYLACTIC REACTION, THE SCHOOL NURSE OR AN INDIVIDUAL IN THE
- 15 SCHOOL WHO IS RESPONSIBLE FOR THE STORAGE AND USE OF EPINEPHRINE
- 16 AUTO-INJECTORS SHALL CONTACT 911 AS SOON AS POSSIBLE.
- 17 (q) (1) A school entity or nonpublic school must inform the <--
- 18 parent or quardian of a student, in writing, that the school
- 19 entity or nonpublic school and its employes and agents,
- 20 including a physician providing standing protocol or
- 21 prescription for school epinephrine auto-injectors, are to incur-
- 22 no liability, except for wilful and wanton misconduct, as a
- 23 result of any injury arising from the self-administration or use
- 24 of an epinephrine auto injector under this section, regardless
- 25 of whether authorization was given by the student's parent or
- 26 guardian or by the student's physician, physician's assistant or
- 27 certified registered nurse practitioner. The parent or quardian
- 28 of the student must sign a statement acknowledging that the
- 29 <u>school entity or nonpublic school and its employes and agents</u>
- 30 are to incur no liability, except for wilful and wanton

- 1 misconduct, as a result of any injury arising from the self-
- 2 administration or use of an epinephrine auto injector under this
- 3 section, regardless of whether authorization was given by the
- 4 student's parent or quardian or by the student's physician,
- 5 physician's assistant or certified registered nurse
- 6 practitioner, and that the parents or quardians must indemnify
- 7 and hold harmless the school entity or nonpublic school and its
- 8 <u>employes and agents against any claims, except a claim based on</u>
- 9 <u>wilful and wanton misconduct, arising out of the self-</u>
- 10 administration or use of an epinephrine auto-injector under this
- 11 section, regardless of whether authorization was given by the
- 12 <u>student's parent or guardian or by the student's physician,</u>
- 13 physician's assistant or certified registered nurse
- 14 <del>practitioner.</del>
- 15 (2) When a trained school employe administers an epinephrine
- 16 auto-injector to a student whom the employe in good faith
- 17 believes is having an anaphylactic reaction, notwithstanding the
- 18 lack of notice to the parent or quardian of the student or the
- 19 absence of the parent's or quardian's signed statement
- 20 acknowledging no liability, except for wilful and wanton
- 21 misconduct, the school entity or nonpublic school and its
- 22 employes and agents, including a physician providing standing
- 23 protocol or prescription for school epinephrine auto-injectors,
- 24 are to incur no liability, except for wilful and wanton
- 25 misconduct, as a result of any injury arising from the use of an
- 26 epinephrine auto injector, regardless of whether authorization
- 27 was given by the student's parent or quardian or by the
- 28 student's physician, physician's assistant or certified
- 29 registered nurse practitioner. AT THE REQUEST OF A PARENT OR
- 30 LEGAL GUARDIAN, A STUDENT SHALL BE EXEMPT FROM SUBSECTIONS (A),

- 1 (F) AND (H). THE PRINCIPAL OF THE SCHOOL IN WHICH THE STUDENT IS
- 2 ENROLLED SHALL NOTIFY ALL PARENTS OR LEGAL GUARDIANS OF THEIR
- 3 ABILITY TO EXEMPT THEIR CHILDREN FROM SUBSECTIONS (A), (F) AND
- 4 (H) BY RETURNING A SIGNED OPT-OUT FORM.
- 5 (H) THE PROVISIONS OF 42 PA.C.S. §§ 8332 (RELATING TO
- 6 EMERGENCY RESPONSE PROVIDER AND BYSTANDER GOOD SAMARITAN CIVIL
- 7 IMMUNITY) AND 8337.1 (RELATING TO CIVIL IMMUNITY OF SCHOOL
- 8 OFFICERS OR EMPLOYEES RELATING TO EMERGENCY CARE, FIRST AID AND
- 9 RESCUE) SHALL APPLY TO A PERSON WHO ADMINISTERS AN EPINEPHRINE
- 10 AUTO-INJECTOR PURSUANT TO THIS SECTION.
- 11 (I) ADMINISTRATION OF AN EPINEPHRINE AUTO-INJECTOR UNDER
- 12 THIS SECTION SHALL COMPLY WITH SECTION 504 OF THE REHABILITATION
- 13 ACT OF 1973 (PUBLIC LAW 93-112, 29 U.S.C. § 794) AND 22 PA. CODE
- 14 CH. 15 (RELATING TO PROTECTED HANDICAPPED STUDENTS).
- 15 (h) (J) As used in this section, "school entity" means a <--
- 16 <u>school district</u>, <u>intermediate unit</u>, <u>charter school</u>, <u>CYBER</u>
- 17 CHARTER SCHOOL, REGIONAL CHARTER SCHOOL or area vocational-
- 18 technical school.
- 19 Section 2. This act shall take effect in 60 days.
