## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in pupils and attendance, further
- providing for home education program.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1327.1(a), (g), (h), (i), (j), (k) and
- 10 (1) of the act of March 10, 1949 (P.L.30, No.14), known as the
- 11 Public School Code of 1949, added December 21, 1988 (P.L.1321,
- 12 No.169), are amended and the section is amended by adding
- 13 subsections to read:
- 14 Section 1327.1. Home Education Program.--
- 15 (a) The following words and phrases when used in this
- 16 section shall have the meanings given to them in this
- 17 subsection:
- 18 "Appropriate education" shall mean a program consisting of

- 1 instruction in the required subjects for the time required in
- 2 this act and in which the student demonstrates sustained
- 3 progress in the overall program.
- 4 "Department" SHALL MEAN the Department of Education of the
- 5 Commonwealth.
- 6 "Hearing examiner" shall not be an officer, employe or agent
- 7 of the Department of Education or of the school district or
- 8 intermediate unit of residence of the child in the home
- 9 education program.
- 10 "Home education program" shall mean a program conducted, in
- 11 compliance with this section, by the parent or guardian or such
- 12 person having legal custody of the child or children.
- "Supervisor" shall mean the parent or guardian or such person
- 14 having legal custody of the child or children who shall be
- 15 responsible for the provision of instruction, provided that such
- 16 person has a high school diploma or its equivalent.
- 17 \* \* \*
- 18 (d.1) (1) Notwithstanding any provision of this act or any <--
- 19 other law or regulation to the contrary, a high school diploma
- 20 awarded by a supervisor OR AN APPROVED DIPLOMA-GRANTING <--
- 21 ORGANIZATION shall be considered as having all the rights and
- 22 privileges afforded by the Commonwealth, a Commonwealth agency,
- 23 <u>including</u>, but not limited to, the Pennsylvania Higher Education
- 24 Assistance Agency, a political subdivision, a local agency and
- 25 an authority or instrumentality of the Commonwealth or a
- 26 political subdivision to a high school diploma awarded under
- 27 this act, if the following criteria are met SUBJECT TO
- 28 <u>SUBPARAGRAPHS (I) AND (II):</u>
- 29 (I) IN THE CASE OF A DIPLOMA AWARDED BY A SUPERVISOR THE <--

30 FOLLOWING SHALL APPLY:

- 1 <del>(1)</del> (A) The student <del>has</del> RECEIVING THE DIPLOMA SHALL HAVE
- 2 completed all the requirements in subsection (d) while enrolled
- 3 in a home education program that is in compliance with this
- 4 section.
- 5 (B) The diploma is issued SHALL BE AWARDED to the
- 6 student on a standardized form to be developed by the department
- 7 and which shall be made available on the department's publicly
- 8 accessible Internet website.
- 9 (C) The diploma is SHALL BE signed by the student's <--
- 10 twelfth grade evaluator in confirmation of the student's
- 11 <u>suitability for graduation.</u>
- 12 (II) IN THE CASE OF A DIPLOMA AWARDED BY AN APPROVED <--
- 13 <u>DIPLOMA-GRANTING ORGANIZATION THE FOLLOWING SHALL APPLY:</u>
- 14 (A) THE STUDENT RECEIVING THE DIPLOMA SHALL HAVE COMPLETED
- 15 ALL THE REQUIREMENTS IN SUBSECTION (D) WHILE ENROLLED IN A HOME
- 16 EDUCATION PROGRAM THAT IS IN COMPLIANCE WITH THIS SECTION.
- 17 (B) THE DIPLOMA SHALL BE AWARDED TO THE STUDENT ON A
- 18 STANDARDIZED FORM TO BE DEVELOPED BY THE ORGANIZATION.
- 19 (2) THE DEPARTMENT SHALL ESTABLISH ELIGIBILITY CRITERIA AND
- 20 AN APPLICATION PROCESS FOR APPROVING DIPLOMA-GRANTING
- 21 ORGANIZATIONS TO AWARD HIGH SCHOOL DIPLOMAS TO STUDENTS ENROLLED
- 22 IN HOME EDUCATION PROGRAMS. THE DEPARTMENT SHALL MAINTAIN A LIST
- 23 OF APPROVED DIPLOMA-GRANTING ORGANIZATIONS AND POST THE LIST ON
- 24 THE DEPARTMENT'S PUBLICLY ACCESSIBLE INTERNET WEBSITE.
- 25 \* \* \*
- 26 (q) When documentation is required by this section to be
- 27 submitted to [the district of residence superintendent or] the
- 28 hearing examiner, [the superintendent or] the hearing examiner
- 29 shall return, upon completion of his review, all such
- 30 documentation to the supervisor of the home education program.

- 1 The [superintendent or] hearing examiner may photocopy all or
- 2 portions of the documentation for his files.
- 3 [(h) Such documentation required by subsection (e)(1) and
- 4 (2) shall be provided to the public school district of residence
- 5 superintendent at the conclusion of each public school year. In
- 6 addition, if the superintendent has a reasonable belief that, at
- 7 any time during the school year, appropriate education may not
- 8 be occurring in the home education program, he may, by certified
- 9 mail, return receipt requested, require documentation pertaining
- 10 to the portfolio of records and materials required by subsection
- 11 (e)(1) to be submitted to the district within fifteen (15) days;
- 12 and documentation pertaining to subsection (e)(2) to be
- 13 submitted to the district within thirty (30) days. If the tests
- 14 as required in subsection (e)(1) have not been administered at
- 15 the time of the receipt of the certified letter by the
- 16 supervisor, the supervisor shall submit the other required
- 17 documentation and shall submit the test results with the
- 18 documentation at the conclusion of the school year.]
- (h.1) An evaluator's certification stating that an
- 20 appropriate education is occurring for the school year under
- 21 review shall be provided by the supervisor to the superintendent
- 22 <u>of the public school district of residence by June 30 of each</u>
- 23 year. If the supervisor fails to submit the certification due on
- 24 June 30 to the superintendent, the superintendent shall send a
- 25 <u>letter by certified mail, return receipt requested, to the</u>
- 26 supervisor of the home education program, stating that the
- 27 <u>certification is past due and notifying the supervisor to submit</u>
- 28 the certification within ten (10) days of receipt of the
- 29 certified letter. If the certification is not submitted within
- 30 that time, the board of school directors shall provide for a

- 1 proper hearing in accordance with subsection (k).
- 2 [(i) If the superintendent of the public school district
- 3 determines, based on the documentation provided, at the end of
- 4 or during the school year, that appropriate education is not
- 5 taking place for the child in the home education program, the
- 6 superintendent shall send a letter by certified mail, return
- 7 receipt requested, to the supervisor of the home education
- 8 program stating that in his opinion appropriate education is not
- 9 taking place for the child in the home education program and
- 10 shall return all documentation, specifying what aspect or
- 11 aspects of the documentation are inadequate.]
- 12 (i.1) If the superintendent has a reasonable belief, at any
- 13 time during the school year, that appropriate education may not
- 14 be occurring in the home education program, he may, by certified
- 15 mail, return receipt requested, require that an evaluation be
- 16 conducted in accordance with subsection (e) (2) and that an
- 17 evaluator's certification stating that an appropriate education
- 18 is occurring for the school year under review, be submitted to
- 19 the district by the supervisor within thirty (30) days of the
- 20 receipt of the certified letter. If the tests, as required in
- 21 subsection (e)(1), have not been administered at the time of the
- 22 receipt of the certified letter by the supervisor, the
- 23 supervisor shall submit the other required documentation to the
- 24 evaluator and the test results to the evaluator with the
- 25 documentation at the conclusion of the school year. If the
- 26 certification is not submitted to the superintendent within
- 27 thirty (30) days of receipt of the certified letter, the board
- 28 of school directors shall provide for a proper hearing in
- 29 accordance with subsection (k).
- 30 [(j) Upon receipt of the certified letter required by

- 1 subsection (i), the supervisor of the home education program
- 2 shall have twenty (20) days to submit additional documentation
- 3 demonstrating that appropriate education is taking place for the
- 4 child in the home education program. If documentation is not
- 5 submitted within that time, the home education program for the
- 6 child shall be out of compliance with the requirements of this
- 7 section and section 1327, and the student shall be promptly
- 8 enrolled in the public school district of residence or a
- 9 nonpublic school or a licensed private academic school.]
- 10 (j.1) If the superintendent has a reasonable belief that the
- 11 home education program is out of compliance with any other
- 12 provisions of this section, the superintendent shall notify the
- 13 <u>supervisor by certified mail, return receipt requested, to</u>
- 14 <u>submit a certification within thirty (30) days indicating that</u>
- 15 the program is in compliance. If the certification is not
- 16 submitted within that time, the board of school directors shall
- 17 provide for a proper hearing in accordance with subsection (k).
- 18 (k) [If the superintendent determines that the additional
- 19 documentation submitted still does not demonstrate that
- 20 appropriate education is taking place in the home education
- 21 program, he shall so notify the supervisor of the home education
- 22 program by certified mail, return receipt requested, and] If a
- 23 <u>hearing is required by the provisions of subsection (g), (h.1)</u>
- 24 or (i.1), the board of school directors shall provide for a
- 25 proper hearing by a duly qualified and impartial hearing
- 26 examiner within thirty (30) days. The examiner shall render a
- 27 decision within fifteen (15) days of the hearing except that he
- 28 may require the establishment of a remedial education plan
- 29 mutually agreed to by the superintendent and supervisor of the
- 30 home education program which shall continue the home education

- 1 program. The decision of the examiner may be appealed by either
- 2 the supervisor of the home education program or the
- 3 superintendent to the Secretary of Education [or], Commonwealth
- 4 Court or court of common pleas.
- 5 (1) If the hearing examiner finds that the [documentation]
- 6 <u>evidence</u> does not indicate that appropriate education is taking
- 7 place in the home education program, the home education program
- 8 for the child shall be out of compliance with the requirements
- 9 of this section and section 1327, and the student shall be
- 10 promptly enrolled in the public school district of residence or
- 11 a nonpublic school or a licensed private academic school. The
- 12 home education program may continue during the time of any
- 13 appeal.
- 14 \* \* \*
- 15 (n) Nothing in this section shall be construed to affect
- 16 Federal or State law relating to special education for students
- 17 with disabilities in home education programs.
- 18 Section 2. This act shall take effect immediately.
