AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An

- epinephrine auto-injectors by school bus drivers. 6
- 7 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 8
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 10
- 11 section to read:
- 12 Section 1414.2. Administration of Epinephrine Auto-injectors
- by School Bus Drivers. -- The provisions of 42 Pa.C.S. §§ 8332 13
- 14 (relating to emergency response provider and bystander good
- 15 Samaritan civil immunity) and 8337.1 (relating to civil immunity
- 16 of school officers or employees relating to emergency care,
- first aid and rescue) shall apply to a school bus driver when 17
- all of the following apply: 18

- 1 (1) The school bus driver administers an epinephrine auto-
- 2 <u>injector to a student in a manner consistent with the policies</u>
- 3 established by all of the following:
- 4 (i) the independent contractor that employs the school bus
- 5 driver, if the school bus driver is employed by an independent
- 6 <u>contractor;</u>
- 7 (ii) the school entity that has contracted with the
- 8 <u>independent contractor</u>, if the school bus driver is employed by
- 9 <u>an independent contractor; and</u>
- 10 (iii) the school entity that employs the school bus driver,
- 11 <u>if the school bus driver is employed by a school entity.</u>
- 12 (2) The school bus driver has successfully completed a
- 13 training program that shall be developed and implemented by the
- 14 Department of Health. The Department of Health shall have ninety
- 15 (90) days from the effective date of this section to develop and
- 16 implement such a training program.
- 17 Section 2. This act shall take effect in 60 days.
