


## Requirements for Cellphone Use in Schools

#### **Provisions and Parameters**

- Guidance, incentives, and requirements
- Policy development and review

#### **Conditions on Use and Exemptions**

- General policies, restrictions, and prohibitions relating to students' use of cellphones
- Exemptions for specified circumstances and teacher discretion

#### **Additional Provisions**

- Implementation and enforcement
- Communication procedures
- Accountability and transparency
- Digital literacy, internet safety and the use of technology and social media in schools

ı	Ala. House Bill 65 (2025)	Public K-12 education	Failed	February 3, 2025	Relates to education, requires the State Board of Education to adopt a model policy restricting the use of cell phones in public K-12 schools, requires each local board of education to adopt a policy based on that model.
	Ala. House Bill 81 (2025)	Public Education	Failed	February 4, 2025	Relates to public kindergarten through 12 education, requires state board of education to adopt model student cell phone use policy, requires local boards of education to adopt cell phone use and storage policy.

House Bill 166 (2025)	FOCUS Act	Adopted / Enacted	May 14, 2025	Establishes the Freeing our Classrooms of Unnecessary Screens for Safety Act, provides that, beginning with the specified school year, no student shall use or operate any wireless communication device in any public elementary or secondary school building or grounds during the instructional day, provides that each local board of education shall adopt an Internet safety policy, provides that the State Department of Education shall develop and approve a course that addresses the risks of using social media.
